**FIRST AMENDMENT TO ON-CALL INDEPENDENT TRACK MAINTENANCE SERVICES CONTRACT
With Gabriel Willaman Railroad Construction**

NEVADA COMMISSION FOR THE RECONSTRUCTION OF THE V&T RAILWAY (“Commission”) and GABRIEL WILLAMAN RAILROAD CONSTRUCTION (“the Contractor”) hereby consent to amend the On-Call Independent Track Maintenance Services Contract dated April 29, 2021 (“Agreement”) as follows:

Whereas, Section 2: Contractor’s Payment provides that the Annual Not to Exceed amount is \$40,000.

Therefore, the Commission and the Contractor agree that the Annual Not to Exceed amount shall be increased by \$54,125, with an amended Annual Not to Exceed amount of \$94,125.

Except as set forth in this Amendment, all the other terms and conditions of the Agreement remain unmodified; and the Agreement shall continue in full force as hereinabove modified.
