MEETING MINUTES

CALL TO ORDER

Chairman Jones called the meeting of the Nevada Commission for the Reconstruction of the V&T Railway to order at 1:09 p.m. and called for the Pledge of Allegiance.

- 2. CHAIRMAN JONES BROUGHT THE FIRST ITEM TO THE COMMISSION'S ATTENTION: APPROVAL OF THE AGENDA The agenda was approved as is.
 - D. Dotson made a motion to approve the Agenda.

Second - M. Santos

Approved - Unanimously

3. CHAIRMAN JONES BROUGHT THE NEXT ITEM TO THE COMMISSION'S ATTENTION: PUBLIC COMMENT ON NON-AGENDIZED ITEMS

No Public Comment.

- 4. CHAIRMAN JONES BROUGHT THE NEXT ITEM TO THE COMMISSION'S ATTENTION: APPROVAL OF MEETING MINUTES
 - M. McBride made a motion to approve the minutes from the February 27, 2020 meeting.

Second - D. Dotson

Approved - Unanimously

- 5. CHAIRMAN JONES BROUGHT THE NEXT ITEM TO THE COMMISSION'S ATTENTION: UPDATE ON FY20 FINANCIAL REPORTS
- E. Spencer explained that the current expense report was included in the agenda package. She explained that the report still required prior year's adjustments, but she and Storey County were getting closer to a true expense report. She explained that the revenue report would be included in the Commission's May agenda package. The revenue numbers matched, but Storey County still needed to add the budget numbers to provide the Commission a full report. She pointed out that the expenses were getting close to the \$1,400,000 budget, but there were still bills to pay for April, May, and June. The #18 repair costs were over \$108,000 this fiscal year and she is sitting on an additional \$47,000 invoice. She pointed out that there were other unforeseen expenses that would also leave expenses higher than budgeted. She said she would be working on an augmented budget to present to the State.
- E. Spencer stated that by next month financials should be ironed out and the Commission can then review them monthly. V&T had only been on the County's TYLER system since January 2020.
- 6. CHAIRMAN JONES BROUGHT THE ITEM TO THE COMMISSION'S ATTENTION: DISCUSS AND APPROVE AGREEMENT WITH STEELE & ASSOCIATES TO PERFORM FY20 AUDIT AND SPECIFY A DEADLINE OF Friday, July 31, 2020 TO HAVE RECORDS SUBMITTED TO THE FIRM IN ORDER TO MEET SPECIAL LICENSE PLATE REPORTING OBLIGATIONS.
- E. Spencer said the fee would be the same forecasted for previous years if they do not have to reconcile our records. E. Spencer explained the July 31 commitment is to have all the information necessary submitted to Steele & Associates so that they can complete it in time for the September 1st deadline for Special License Plate reporting.
 - D. Dotson made a motion to approve the agreement with Steele & Associates to perform the FY20 audit and specify a deadline of July 31st to have the completed audit to the special license plate auditors.

Second - M. Santos

Approved Unanimously

7. FOR POSSIBLE ACTION: DISCUSS OPTIONS FOR THE 2020 REGULAR TRAIN AND POLAR EXPRESS SEASONS, PLUS REVIEW PROJECTED REVENUE AND EXPENSES RELATING TO THE ABBREVIATED SEASONS

- E. Spencer explained that due to the COVID-19 pandemic and CDC guidelines and the State's phased reopening plan the Commission needed to discuss the upcoming 2020 train season further and the Polar Express and make some choices.
- M. McBride reported on the Governor's Report to the counties regarding the opening of businesses within Nevada. He said the state address will be at 5 p.m. on YouTube and possibly one of the local TV channels as well. He'd also heard some chatter that school will be out for the rest of the school year and it is possible that it will start earlier and that will have an impact on any type of train operations and a reduction of people in Virginia City.
- E. Spencer confirmed that the Governor's address to the State would be at 5 p.m. on various local stations.

Mike Draper spoke to the board and encouraged that everyone to put thought into how to address consumer confidence. He said following basic guidelines will be a necessity, but there are other things we can do to make people feel confident when that time comes.

- E. Spencer shared her discussion with Carla Wilson, the Polar Express production manager. She questioned whether she would be able to get her cast back to perform if there is a second wave. Those are things they should know more about in August. Because it is unknown if the Polar Express will run E. Spencer has been encouraging people to buy gift certificates or allowing them to purchase with the understanding that if this year's event is canceled they can use their credit towards Polar Express 2021. She said she also has a list of people wanting to buy tickets for the theme trains this summer. Most people are willing to wait to know more. Most of the calls to the V&T ticket phoneline are those wishing to cancel their rides.
- E. Spencer explained that because of the reduced numbers of people they can put on a passenger car they will need three passenger cars just to cover the cost of the train. She also informed the commission members that based on the Governor's guidelines the train would qualify under the last phase as they would be 120 plus passengers.
- S. Jones stated that it was his understanding that regardless of the timeline, social distancing would be with us for a long time. It would probably be until later when we get a vaccine. He could not see being able to run the Polar Express this year. In addition to the expenses already paid for the event there would be extra expense to sanitizing the cars and providing PPE to the public. The social distancing will make it impossible to use the covered staging area and we do not know what the weather will be like. He could not see running at a loss. He had no problem waiting to make the decision, but he felt positive that we will not be running the Polar Express.
- N. Marano wanted to confirm that S. Jones was addressing the current year's Polar Express. He said he agreed that the train could go dark for the remainder of this calendar year and possibly next year. He questioned the change of the business model.
- S. Jones agreed, and said he also agreed with M. Draper that the fiscal impacts on travelers could be severe.
- M. Santos agreed, and said the unemployed would not have disposable income to spend and said that going dark this year would give us a chance to regroup to determine what will come out at the end as far as rules and regulations. Waiting for a vaccine and regaining people's confidence is critical. He said that running the trains this year will include a liability issue. If someone got sick on one of our trains that could come back on us.
- S. Jones asked the commissioners if they would like to make a change to the discussion and say that there would be no regular train season this year and decide on the Polar Express later?

- D. Dotson said he thought that would be a wise decision so that E. Spencer could make up a budget for FY20. He recommended still budgeting for the Polar Express this year, but we did not have to do it. He said to budget it for a low turnout and then keep the last two months of the fiscal year and the Mother's Day event. The Commission could review it again in a couple of months.
- M. Draper spoke to the Commission and said that activities would be fewer for the near future, but once the train could meet the conditions, it would be able to capitalize on it.
 - D. Dotson made a motion that they have the general manager build a budget with the 2020 train season dark but with a Polar Express season with the decision to be made next month.
 - N. Marano Seconded Approved Unanimously
- (M. McBride informed the Commission that he needed to attend the conference call with the Governor and would need to leave the meeting. He would return once the call was over.)

8. FOR POSSIBLE ACTION: DISCUSS AND POSSIBLY APPROVE A REIMBURSEMENT REQUEST TO STOREY COUNTY AS PER V&T'S CURENT INTERLOCAL AGREEMENT

- E. Spencer invited A. Osborne to speak on it, and he deferred to D. Dotson and J. McCain.
- J. McCain asked what information they were requesting.
- E. Spencer reminded them that the item had been placed on the February V&T Commission agenda along with a letter requesting the reimbursement, but it had been tabled for this month by request. She asked if the County was leaning in favor or against the request.
- A. Osborne said there was one question regarding the admin support reimbursement. He said the other two were separate.
- J. McCain said they discussed the reimbursement section for the FY19 track maintenance and the FY20 track maintenance and it would need to go before their board.
- E. Spencer explained that the track maintenance was for FY19 & FY20 and that the admin reimbursement was due to hiring a bookkeeper to track records for the V&T which was not originally budgeted and was in addition to Storey County's services. She said V&T's auditor had to review and then reconcile Storey County's records to V&T's inhouse records costing twice as much as a normal audit.
- A. Osborne said the track maintenance was good with them, but that there were some questions relating to the admin reimbursement and it would take more follow-up.
- E. Spencer asked if A. Osborne would like to have a meeting prior to the next Commission to discuss it.
- A. Osborne said that it was his opinion that she meets with him, J. McCain and Vanessa Steven's to explain the details.
- J. McCain agreed.
- S. Jones asked if E. Spencer was good with a meeting and she answered that it was a good plan.
- S. Jones asked if the reimbursement request should be tabled again.

- A. Osborne asked if the Commission wanted to approve the track maintenance, \$74,000 and \$75,000, and remove the \$50,000 for further discussion.
- S. jones asked what was easiest for accounting.
- D. Dotson recommended accepting the track maintenance reimbursement so that E. Spencer could pay a few bills and balance FY20. He said it would be \$148,630.49.
- E. Spencer asked him to verify his recommendation.
- D. Dotson said to accept the \$148,630.49 reimbursement and table the \$50,000 admin reimbursement until after the meeting.
- S. Jones asked D. Dotson to make his statement a motion.
 - D. Dotson responded, so moved.
 - M. Santos Seconded
- **Approved Unanimously**
- 9. CHAIRMAN JONES BROUGHT UP THE NEXT ITEM FOR DISCUSSION AND POSSIBLE ACTION: APPROVAL OF A REVISED INTERLOCAL AGREEMENT BETWEEN V&T RAILWAY AND STOREY COUNTY TO COMMENCE JULY 1, 2020.
- E. Spencer informed the Commission that a copy of the revised MOU with Storey County was included in their package along with the adjustments and comments. She said that she, D. Dotson, A. Osborne, V. Stevens, K. Loomis, M. Rowe and S. Jones had all had the chance to review the document. She asked for D. Dotson to lead the discussion as he represented the V&T Commission for the meeting to discuss the changes.
- D. Dotson said it was just cleaning up for the times. He said the financial services portion could be adjusted in time. He said it would be minimal at the beginning since the trains would be dark for a while. He said it was hourly for now and a two-year term. It could be adjusted with a 30-day notice. It would make it easier to budget and he saw no issues with it being approved today.
- A. Osborne clarified that it would be for 24 months and then after that if nothing happened it would default to a 50/50 cost share.
- S. Jones asked for any other comment and thanked D. Dotson for his work on it.
- M. Santos thanked D. Dotson as well.
- A. Osborne said it would be approved around first part of July by the Storey County Commission.
- E. Spencer asked if she would need to wait until that time or could she add it their proposed FY21 budget that needed to be approved before the end of May.
- D. Dotson and A. Osborne stated they expected Storey County to approve the revisions.
- J. McCain informed E. Spencer that due to the strict budget deadline for the FY21 budget submission she should add the revised amount to the V&T budget.
 - M. Santos made a motion to approve the revised MOU with Storey County as presented to the V&T Railway Commission.

10. CHAIRMAN JONES BROUGHT THE NEXT ITEM TO THE COMMISSION'S ATTENTION: PROGRESS REPORT ON THE ENGINE #18 OVERHAUL AND APPROVE ADDITONAL EXPENDITURES OVER \$5,000

E. Spencer said he had been in touch with T. Gray and the #18 Steam engine is near completion. She said they still needed to work out the lease agreement for the #18. It should be operational this year. T. Gray projected another \$25,000 needed to finish it off in the coming year. T. Gray also forecasted that the Commission would need to buy new siding for the tender. E. Spencer explained that the Commission put a lot of money into the #18 engine this year and that they were over the half -million-dollar mark for the total cost for its refurbishment. She said there was another invoice for work performed from Aug. of last year to Feb. of this year for work and that it was for \$47,000. This fiscal year alone the Commission has put nearly \$150,000 of unbudgeted funds into the #18.

E. Spencer explained that all unbudgeted items were an issue and because of it she has started a purchase order system for any expenses of \$5,000 or more, budgeted or otherwise. In some cases, it would be an estimate, but she would bring these items to the attention of the Commission for their approval. She explained that she put the PO system into place because in the past it has caused them to overextend their finances and that these types of expenses were hard to foresee. She explained that as a government entity it was important to be transparent and that it was a good policy to have.

S. Jones asked if the PO system would be something going forward and E. Spencer confirmed that it would be for any future expenses over \$5,000 whether it be for the #18, track maintenance, or marketing. She also said there could be the option of Mike Santos, as the Treasurer, to sign the POs. She felt it important that the Commission be fully aware of the larger purchases.

M. Santos made a motion that they accept the progress report on the #18 by E. Spencer and that any further expenses over \$5,000 go before the Commission for their review and approval.

D. Dotson seconded

Approved Unanimously

11. FOR DISCUSSION AND POSSIBLE ACTION: APPROVAL TO PUT CERTAIN CONTRACTS ON A MONTH TO MONTH BASIS.

E. Spencer explained that there had been much discussion about reviewing contracts in the previous months. She said that Argentum's contract had expired and Gabe Willaman's contract was going to be on the agenda and that even though her contract did not expire for another year that her contract was going to be reviewed. It was an exercise for the commission to fully understand who did what. But due to the current situation she recommended they go month to month with the contracts and pay hourly rates. She had been working on the FY21 budget and forecasting contract expenses was difficult. She spoke with Argentum knowing that V&T would not be marketing for some time. She said M. Draper had offered to help us when we needed it. She explained that she also spoke with G. Willaman and that he is aware of the lack of need for track inspections since the trains would not be running.

M. Santos asked to see the contracts before they are approved.

E. Spencer clarified that the expired contracts would not be renewed until the trains were back in operation.

- D. Dotson asked E. Spencer about her contract as general manager and if she would be cutting back hours or something like a possible furlough with limited hours. She said currently she is working fulltime, since taking over other duties, but that she would expect to be cutting back if the Polar Express was cancelled.
- S. Jones said he preferred to keep things as is for now.
- G. Willaman asked about continuing with the signal inspections and said it would be more costly to shut them down.
- E. Spencer said she would have a conversation with G. Willaman and would get his recommendation for the signal inspections.
- S. Jones asked for a motion.
 - N. Marano made a motion to allow the General Manager to maintain the expired contracts on a month to month, and to use the current professionals on an hourly basis.
 - M. Santos Seconded

Approved Unanimously

(N. Marano let the Commission know he needed to drop off to do another ZOOM interview.)

12. CHAIRMAN JONES BROUGHT THE NEXT ITEM TO THE COMMISSION'S ATTENTION FOR DISCUSSION ONLY: UPDATE ON THE PROPOSED RAILBIKE OPERATION

- M. Santos said E. Spencer had been speaking with some private railbike vendors who would lease the track that goes into the canyon. E. Spencer would serve as a liaison between railbike business and the Commission. It could result in some income for the Commission. It is an opportunity we might want to look in to. He wanted to know how the Commission felt about it. If it is something the Commission wanted to explore, they will put together a full proposal for the Commission to consider.
- S. Jones agreed that it was worth looking into leasing the track.
- (M. McBride returned to the meeting.)

13. CHAIRMAN JONES BROUGHT THE NEXT ITEM TO THE COMMISSION'S ATTENTION: MARKETING UPDATE BY ARGENTUM PARTNERS

- M. Ellery said they had put together a full marketing overview for July to December, but in light of the situation and decision made by the Commission it will be set aside. The plan is to market the trains, and keeping COVID in mind, they are focusing on social media trivia. My V&T moment and historical photos of the train. Updated language on the site to include COVID message and focusing on gift certificates.
- M. Draper considers us all family and they will be available and committed to help to get us back to being successful.
- 14. CHAIRMAN JONES BROUGHT THE NEXT ITEM TO THE COMMISSION'S ATTENTION FOR DISCUSSION ONLY: THE GENERAL MANAGER'S REPORT:
- E. Spencer stated she had no more comments.

15. CHAIRMAN JONES BROUGHT THE NEXT ITEM TO THE COMMISSION'S ATTENTION: ATTORNEY'S REPORT.

E. Spencer reported on her interaction with M. Rowe. She said she was trying to determine V&T's liability issues relating to COVID-19 and CDC requirements and was told that they needed to follow CDC and State guidelines closely and go beyond if necessary, but that anyone can sue for anything. They told her that if staff got ill, they could use workman comp insurance.

16. CHAIRMAN JONES BROUGHT THE NEXT ITEM TO THE COMMISSION'S ATTENTION: FOR DISCUSSION ONLY: NEXT MEETING DATE(S) AND AGENDA ITEMS:

V&T Railway Commission will have two meeting in May. The first meeting will be the FY21 Budget Hearing and the second would be a regular board meeting to discuss where they were in the Nevada reopening phases and the FY20 Augmented Budget.

17. CHAIRMAN JONES BROUGHT THE NEXT ITEM TO THE COMMISION'S ATTENTION: ADJOURNMENT OF THE MEETING.
